It is to submit that, the kayakalp implementation for the financial year 2017-18, will be extended to all UPHCs in the State of Telangana. Total UPHCs are 249, PHCs - 504, CHC - 93, AHs - 31 and DHs - 6, total facilities in the state of Telangana - 883, = 687.

Itissubmittedthat, the State level Awareness meeting was conducted on 30.08.2017 at IIHFW, Vengal Raonagar Hyd. The District and facility level trainings have been completed by District Quality Assurance Managers (DQAMs) with the support of DMHOs, District Head quarter Superintendents and Medical Superintendents of the facilities in respective districts.

In this regards, to strengthen the kayakalp Programme the NHM, RoP released the budget towards the Kayakalp Trainings at FMR Code B15.2.7.1 and Kayakalp Internal and Peer Assessments at FMR Code B15.2.7.2.
