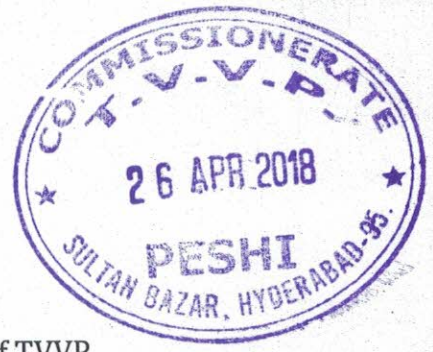


I invite kind attention of the Commissioner (TVVP) to the letter referred above, wherein option forms were sought from the Civil Assistant Surgeons (Specialists) under the administrative control of DPH&FW.

Accordingly, another (21) Civil Assistant Surgeons (Specialists) have furnished their option for absorptions of their services into TVVP, which are enclosed herewith along with a statement in the prescribed proforma.

In this connection, it is informed that a copy of the enclosed list is being furnished to the Vigilance Cell of this office, who shall verify and certify on the charges pending, if any against the said doctors who have opted for absorption of their services into TVVP, at the earliest.

The Commissioner (TVVP) is requested to issue final absorption orders only on receipt of NCC (No-charge pending certificate) from the VC section of DPH&FW, TS Hyderabad. Also, the Commissioner (TVVP) is further requested to ascertain charges pending, if any, against those CAS who are working on foreign service deputation basis in the institutions under TVVP control.

It is further informed that spouse certificates have not been furnished by these CAS. As such, spouse certificate may invariably be verified before counselling for reposting or issuance of absorption orders.
